




# Bullying – why should we fight against it?



Violence against children, and especially bullying is a widespread phenomenon and a major reason for children feeling unsafe at school, in their homes and in their leisure-time. Bullying is often connected with a feeling of shame and powerlessness. It is a more or less "invisible" problem, too frequently neglected by the surrounding society. Bullying is a wide-spread problem; studies in the Baltic countries have shown that between 15–25% of school children are affected by it.

Bullying can be devastating for the children affected by it, if the patterns are not broken; scars are often left well into adulthood. Traditionally bullying has been noticed in the school environment, but lately and especially with the expansion of the Internet bullying can be everywhere and always. The physical, verbal, psychological and virtual means of demonstrating power and powerlessness need to be combated by all means available in society. Everyone is important. Everyone can help.

#### Friends Across Borders – a regional effort against bullying

The main aim of Friends Across Borders is to put the spotlight on and work against bullying in the three Baltic countries Estonia, Latvia and Lithuania. Activities will encompass prevention of bullying in schools, supporting victims of bullying as well as bullies, information and awareness-raising among the general public and promoting innovative methods to better tackle issues concerning bullying.

Save the Children Sweden is coordinating the project, and assists with professional knowledge on the subject in cooperation with Friends. Swedbank is the project sponsors.
