

## ***Public opinion monitoring in Ukraine: July 2009***

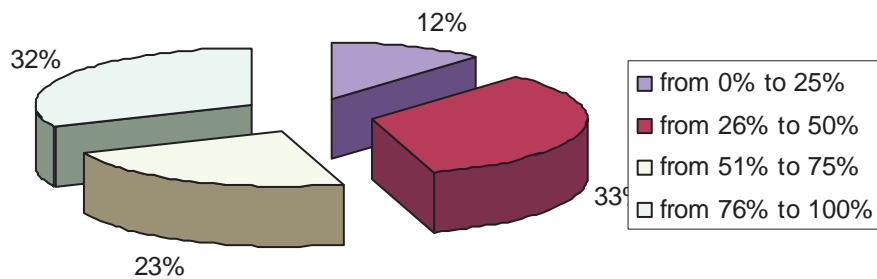
The survey was conducted in the period from 6<sup>th</sup> till 12<sup>th</sup> of July 2009 by the company “ADV Energy”.

Information was collected during ‘face to face’ individual interviews at the locations of respondents’ residences.

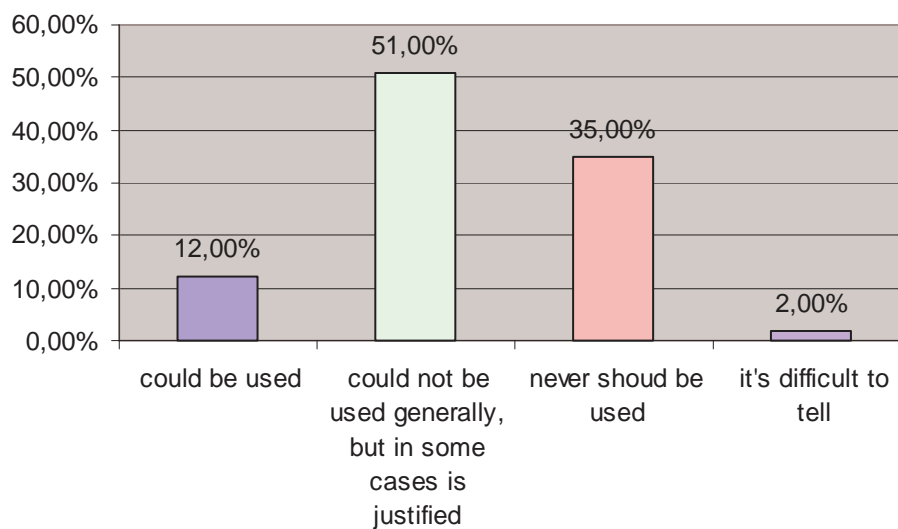
1501 respondents were interviewed. All respondents were of the age over 25 and have their own children.

### Number of children subjected corporal punishment on the respondents' opinion



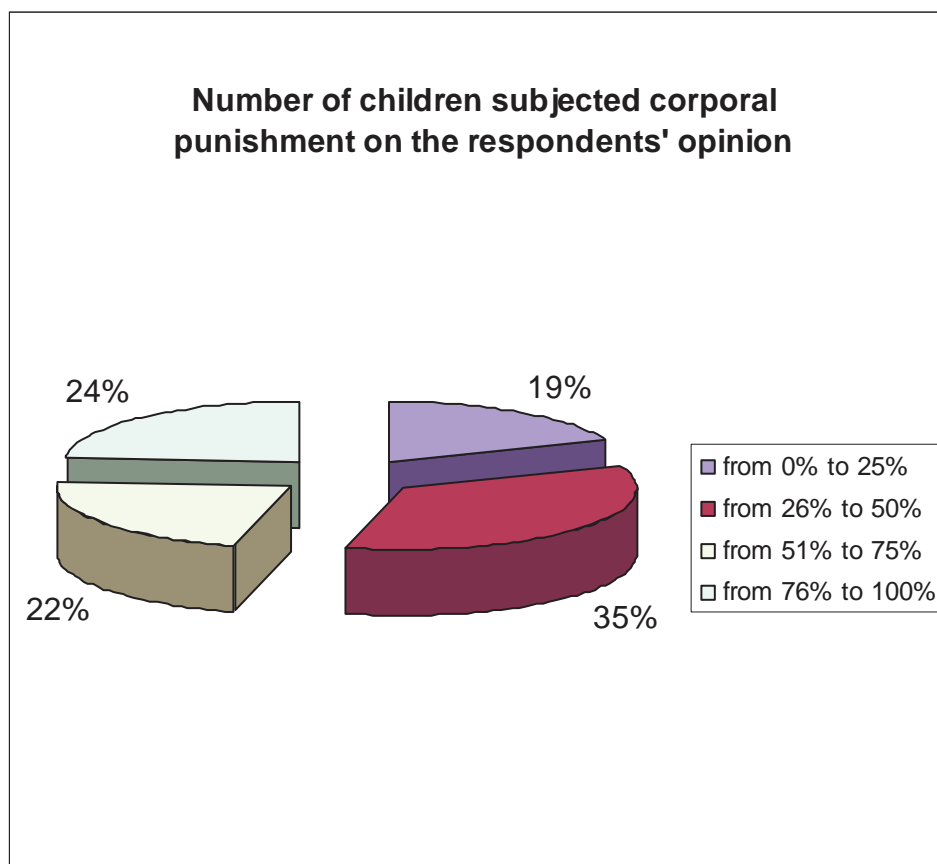

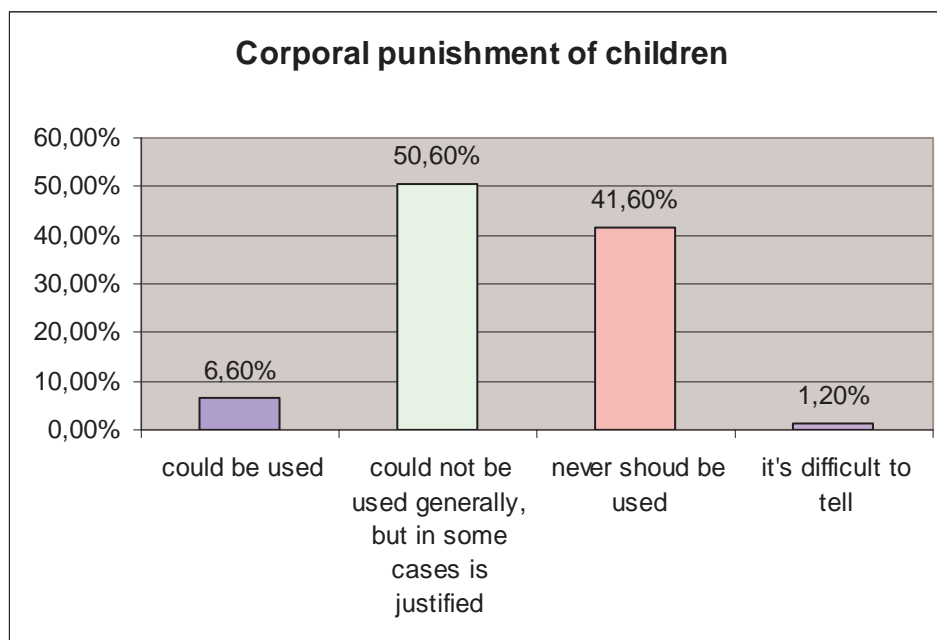

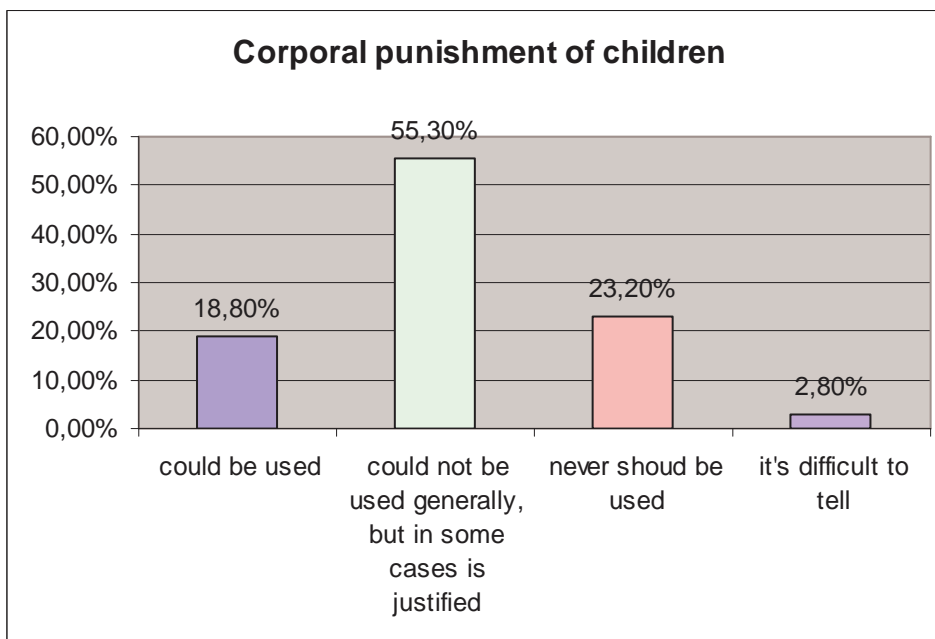
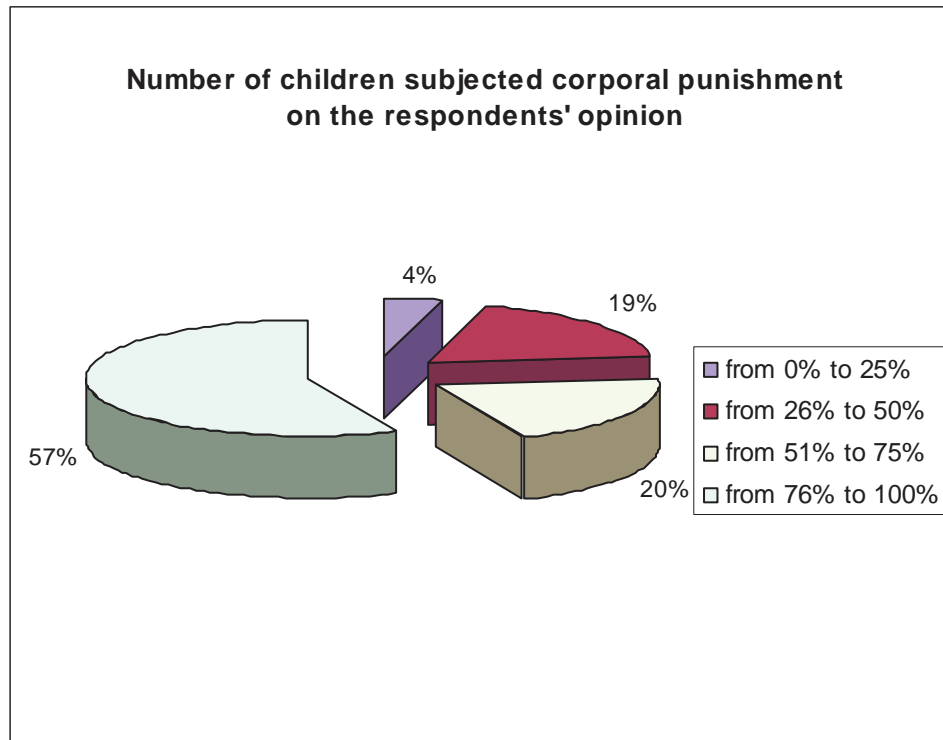

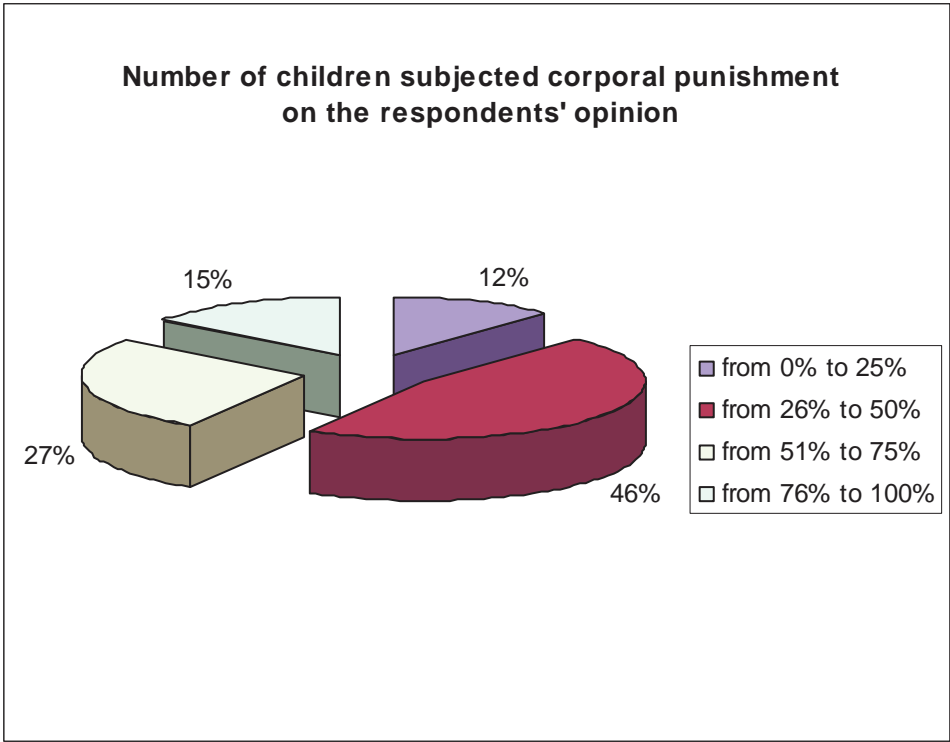

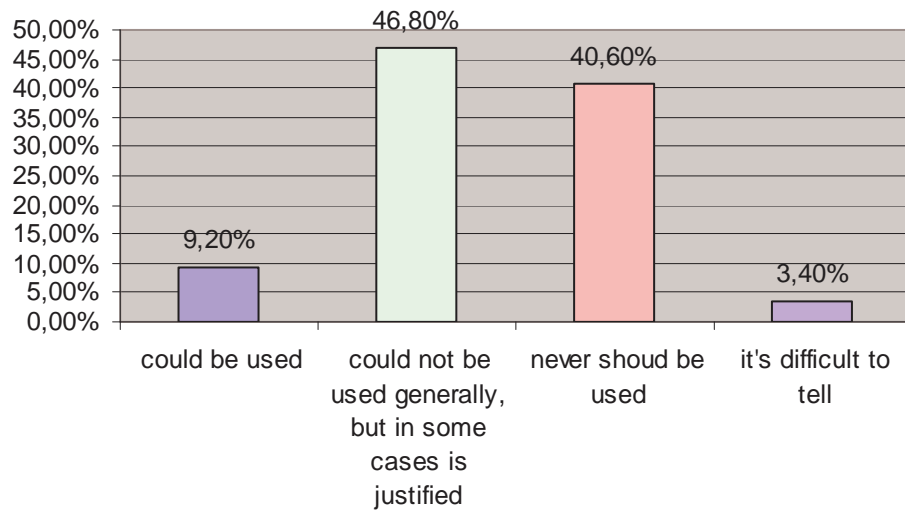

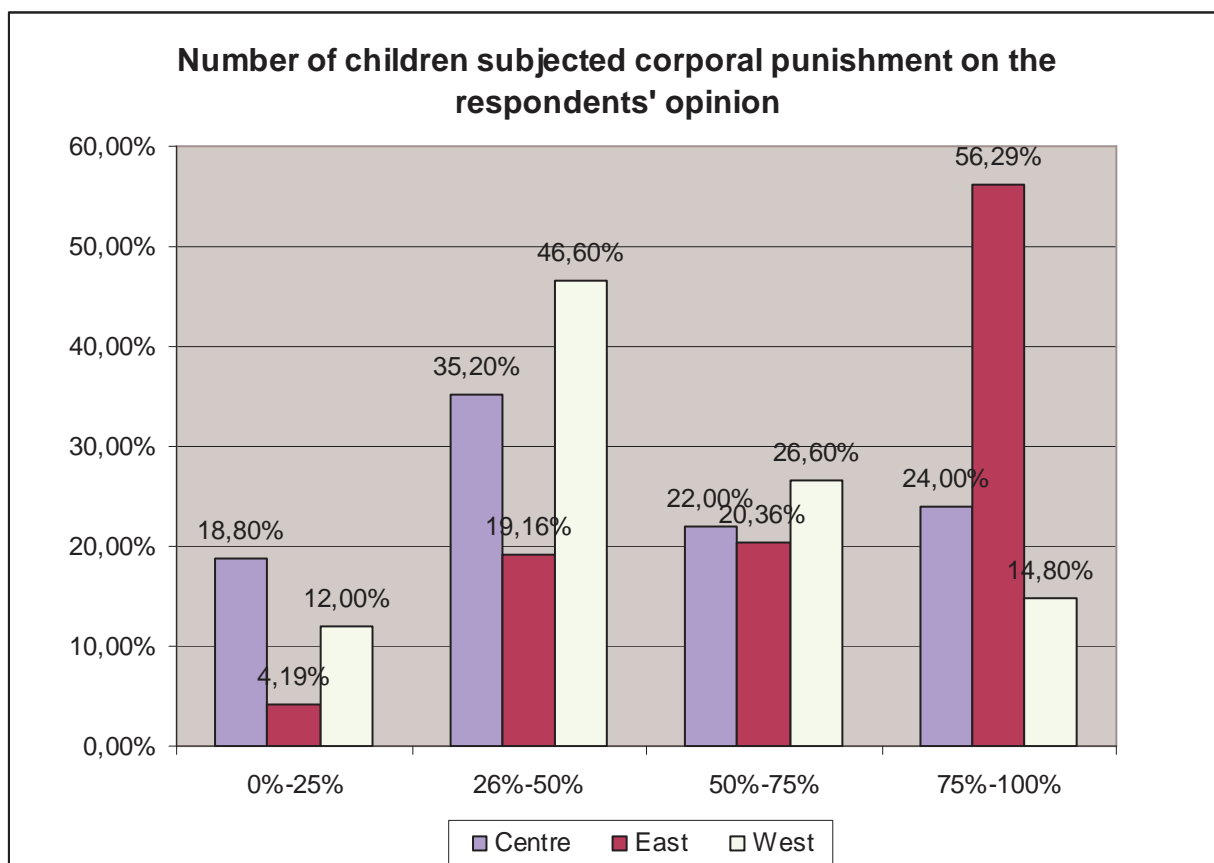
